## **NOTIFICATION**

Let this serve as notification for the election to be held concerning (2) Board of Trustee positions which will be expiring on December 31, 2017.

Qualifying will begin on Monday, July 17, 2017 and end on Friday, July 28, 2017 at 4:30 p.m.  
Anyone interested in being elected to the Board of Trustees will need to fill out the Qualifying Form and return it to this office, **between** the qualifying dates listed and postmarked and received by **July 28, 2017 @ 4:30 pm**. All qualifying forms **MUST** be mailed to the ROVERS office. In addition to the qualifying form included with this letter, an employee may access the website to obtain the qualifying form. The 2011 Legislative Session brought changes to our system. As of that date ALL active members of the Registrars of Voters Employees' Retirement System will now be able to participate in the election process for Board of Trustees positions. In the past, these positions were elected at the Annual Seminar and not all members could be in attendance for the election.

## **QUALIFICATIONS**

1. Any member with 10 years of creditable service [ R.S.11:2091.B.3 ] who is currently participating in ROVERS and employed in the Registrar of Voters Office as of June 30, 2017 will be eligible to qualify for this election.
2. Board members can serve for 2 complete term limits beginning 1/1/2012.

## **VOTING PROCESS**

You will be mailed ballots at your home to be voted and returned to this office by a specified date. Election results will be posted on the system website and will also be forwarded to your Registrar of Voters to be posted in your office for public inspection.

Candidates should verify, prior to the last day with ROVERS office, that their application has been received. This year (2017) there will be 2 Board positions up for election. The 2 present Board member holding this office is:
