QUALIFICATIONS:

Must be an active contributing member of the system and have at least five (5) years of creditable service in the Registrars of Voters Employees' Retirement System. Trustees may serve no more than three (3) consecutive four (4) year terms. If an elected trustee elects to participate in DROP after his term has commenced, he may continue to serve for the remainder of the term for which he was elected; however, if he otherwise separates from service, his term shall expire. (R.S.11:2091.B.3)

Any eligible member interested in qualifying as a candidate for the Board of Trustees must complete the attached qualifying form and return it to this office between July 21, 2025, and July 25, 2025. The qualifying form must be postmarked on or after July 21, 2025, and received by the ROVERS office no later than July 25, 2025, by 4:30 pm. The qualifying form is also posted on the website www.larovers.com. Candidates should confirm, before the last day, with the ROVERS office, that their application has been received.
